THIS AGREEMENT is entered into between Seattle Scuba Schools and the above signed and their guardian, hereinafter "RENTOR," for the rental of scuba and /or skin diving equipment. This AGREEMENT is a release of the RENTOR'S rights to sue for injuries or death resulting from the rental and / or use of this equipment. RENTOR expressly assumes all risks of skin and / or scuba diving related in any way to the rental and / or use of this equipment. RENTOR hereby acknowledges receipt of the equipment designated in this form, and, if any of this equipment is to be used for scuba diving, that RENTOR is a certified scuba diver or student in a scuba diving course / program under the supervision of a certified scuba instructor.

RENTOR also understands that Seattle Scuba Schools, its employees, owners, officers, or agents (hereinafter "Released Parties"), shall not be held liable or responsible in any way for any injury, death or other damages to RENTOR or his / her family, heirs, or assigns which may occur as a result of the rental and/or use of the equipment, or as a result of product defect, or the negligence of any party, including the Released Parties, whether passive or active.

Rentor has inspected this equipment and acknowledge that it is in good working order including checking the quantity of air in any scuba tank(s) rented. Rentor agrees to rinse all equipment free of sand and salt with fresh water after use and return all equipment by the date due. Rentor agrees to pay a cleaning fee of \$20 for gear returned unrinsed. Rentor accepts full financial responsibility, as outlined below, for any equipment not returned. Rentor agrees to pay full rental fees for each late day, or portion thereof. Rentor agrees to payment of full replacement cost for any equipment not returned. Rentor agrees to return all rented tanks with no less than 300 psi of air still in them. Rentor agrees to pay a maintenance fee of \$20 per tank for any tank returned with less than 300 psi remaining. In signing Rentor agrees to pay all rental fees as well as replacement and maintenance fees as outlined above. Rentor understands the terms herein are contractual and not a mere recital, and has signed this document of my own free act and with knowledge that I hereby agree to waive my legal rights. I further agree if any provision of this Agreement is found to be unenforceable or invalid, that provision shall be severed from this Agreement. The remainder of this Agreement will then be construed as though the unenforceable provision had never been contained herein.

I understand and agree that I am not only giving up my right to sue the Released Parties but also any rights my heirs, assigns, or beneficiaries may have to sue the Released Parties resulting from my death. I further represent I have the authority to do so and that my heirs, assigns, or beneficiaries will be stopped from claiming otherwise because of my representations to the Released Parties.
